

Very special thank you to the Bates family who have continued to support BZE in memory of Jennifer Bates. Kathryn and Jordi's fundraising has directly supported our work in the Hunter region with increased staff, in particular supporting our community engagement work. We are honoured and grateful.

This was also the year we farewelled Vanessa Petrie. During her three years as CEO, Vanessa led some truly groundbreaking pieces of research and community development. Vanessa's dedication and hard work saw BZE receive prestigious awards for our high-quality research as well as our unique volunteer powered research model. ### Premier's Sustainability Awards (Victoria)

The team of volunteers who helped Beyond Zero Emissions (BZE) produce the Electrifying Industry report won the inaugural Environmental Volunteering Award at the Premier's Sustainability Awards (Victoria). The Premier's Sustainability Awards recognise and celebrate Victorians who are leading the way to a sustainable future.

The Electrifying Industry report shows how manufacturers can generate heat differently, through the smart use of renewable electricity. By electrifying industry, Australia can eliminate up to 8% of national emissions. More than 50 volunteers were involved in the project, including researchers, editors, expert consultants and peer reviewers, and as members of the advisory committee.

## **Million Jobs Plan**

Creating a prosperous, zero carbon future for Australia has always been the foundation of BZE's mission but this year an unprecedented global crisis became a major unexpected impetus.

The plan identifies the best investments across:

- renewable energy and associated transmission infrastructure,
  - energy-efficient building retrofits and new social housing,
  - transitioning manufacturing, mining and minerals processing to green energy,
  - on-shore materials recycling,
  - · electrified transport,
  - land restoration, indigenous-led ranger programs and soil carbon,
  - · training education and research.

Our plan was delivered in a massive collaboration between our Zero Carbon Communities, Investors, Government, Union and Business stakeholders. More

As the global pandemic unfolded in March 2020, BZE staff, volunteers and stakeholders recognised that the scale of the crisis would call for ambitious solutions to repower our economy and communities - and the Million Jobs Plan was born.

BZE researchers drew from our ten years of decarbonisation plans to highlight how the most jobsintensive nation building projects could deliver more than a million secure, well paid new jobs while also modernising our industries and capitalising on private investment.

The **Million Jobs Plan** sets Australia up for the next 50 years of economic growth, and showcases the social benefits of decarbonisation projects in our regions where climate change and the decline of fossil fuel industries are already threatening the wellbeing of communities.

One of BZE's major projects planned for the year was developing a strategy for transitioning the Hunter Valley to a new zero emissions future after a long history of reliance on fossil fuels. But when the COVID 19 pandemic struck, BZE quickly decided a much bigger picture was at stake in the wake of the biggest global economic shock since the Great Depression.

BZE's mission came into sharp focus as a huge opportunity in the uncertain post-COVID world. BZE quickly pivoted from completing its Hunter Valley strategy to drawing a road map for Australia's recovery based on fast tracking many of BZE's existing strategies.

Starting in April, BZE gathered together the best minds in the environment, business and union movements to create a 20 year recession-busting plan. The result is the **Million Jobs Plan**, announced in June, creating at least a million new viable jobs in urban and regional Australia to help deal with the post COVID economy and the loss of thousands of existing jobs. Our MJP researchers pulled together a database of over 600 projects representing billions of dollars in private investment. All based on a zero carbon future with renewable energy, the MJP identifies new business investment and job growth in:

- building 90 Gw of renewable energy and associated transmission infrastructure,
- · energy-efficient buildings,
- transitioning manufacturing, mining and minerals processing to green energy
- · materials recycling,
- · electrified transport
- · land restoration and soil carbon,
- · training education and research.

The **Million Jobs Plan** was launched at the end of the financial year - we're including a sneak peek at some of the outcomes generated after the launch.

#### 'We need a destination': Mike Cannon-Brookes backs plan for 1.8 million jobs

'We can use this as an opportunity to electrify so much of our economy in lots of different ways he said.

The million jobs plan outlines a job creation framework for the next five years based on the acceleration of new energy transmission and storage projects, the implementation of a national housing pretoff program for low-income households and the building of 150,000 new zeroenergy social housing dwellings.

The plan also calls for building electrified transport infrastructure, such as electric bus fleets; land restoration; the upgrade of aluminium smelters; and the development of 'green steel' produced with hydrogen.

Mr Cannon-Brookes said Australia had the assets and resources, like sun and wind, to lead in resourceables and low-energy and pointed to his investment in the SunCable project to build the world's largest baile fram, storage facility and a cable to Singapore. 



## **Collie at the Crossroads**

The transition to clean energy comes with great challenges, in particular for those communities that have traditionally relied on fossil fuel industries for jobs. Australians living in our coal, oil and gas regions worry about their future as the global trend towards renewables intensifies and demand for fossil fuel drops.

The coal town of Collie in the south west part of Western Australia, population 9,000, is one such community. BZE prepared and launched a new report specifically for Collie outlining a path to secure its economic future.

BZE's *Collie at the Crossroads* report was launched in November 2019. It showed how industries based on clean technologies, underpinned by a commitment from WA for 100 per cent renewable energy in the grid, can replace the ailing coal industry as the basis for Collie's economic future.

The report shows that the rapid rollout of renewable energy in WA could spark new industries and jobs in a range of activities including

- building and supply of wind, solar and pumped-hydro power generators and associated infrastructure,
- renewable hydrogen production, a hugely important clean fuel,
- using renewable clean energy to manufacture low-carbon building materials such as engineered timber, steel and cement,
- recycling of renewable energy materials such as batteries and solar PV panels,
- · retrofitting buildings for energy efficiency.

The report outlines the potential to create over 1,750 secure well paid jobs for the current highly skilled workforce in Collie, more than offsetting 1,250 positions in the coal industry.

*Collie at the Crossroads* received broad community support at the launch. Greg Busson, Secretary of the CFMEU Western Australian District Mining and Energy Division welcomed the report. He acknowledged the importance of involving Collie workers in planning the region's energy transition. This would ensure their needs, and the community's needs, remained front and centre.

Shire of Collie President, Cr Sarah Stanley, commended the report for its practical suggestions on how government can help drive investment in sustainable industries as well as support workers and community.

Following the release of the report, the WA government introduced the Collie Futures Fund - a \$20M fund to drive economic diversification, create jobs in the Collie, and create COVID-19 response plans. See www.cleanstate.org.au.

# **The 10 Gigawatt Vision**

Since the launch in June 2019 of BZE's vision for transforming the Northern Territory economy through renewable energy, there has been significant progress in implementation of the plan.

The 10 Gigawatt Vision: How renewable energy can power jobs and investment in the Northern Territory demonstrated how investment in 10 gigawatts of renewables by 2030 could create over 8,000 new jobs and over \$2 billion in new annual revenue. The plan would remove 20 billion tonnes of carbon emissions, significantly helping Australia mitigate the impact of climate change.

Promoted in partnership with the Environment Centre NT, the plan outlines how renewable energy can turbocharge the NT economy with lower energy prices for consumers and businesses, creating long term jobs and investment.

Our report had a major impact on the Northern Territory government's economic plans. It also raised public understanding of how renewable energy can transform the Territory's economic prospects.

### This year the report:

- had a major impact on government policy with the returned Labor government adopting many of its key ideas into their Climate Change Reponse - Towards 2050, energy policies and election platform
- a kick start for investment in Sun Cable's Australia-ASEAN Power Link project, exporting renewable energy from what could become the world's biggest solar farm in the NT's Tennant Creek, to Singapore
- formed the basis of the Environment Centre NT election campaign Repower NT. The campaign secured across-the-board, bipartisan support for renewable energy for the first time in an NT election including commitments to the 50% renewable energy target by 2030
- the appointment in May of BZE chair Eytan Lenko to the board of the NT Economic Reconstruction Commission, set up to manage the Territory's post COVID 19 economic recovery.

*The 10 Gigawatt Vision* was entered for an Environmental Philanthropy award held by Philanthropy Australia, with the winners to be announced in November 2020.

Zero Carbon Communities is BZE's grassroots initiative designed to encourage and support local communities to create their own pathways to a zero emissions future.




There are dozens of Zero Carbon Communities around Australia working to achieve meaningful emissions reductions and improve sustainability, by influencing activities at their own local level.

The Zero Carbon Communities program provides resources and tools to support these local groups.

### Achievements for the Zero Carbon Communities this year included:

- We registered over 50 new Zero Carbon Communities
- We developed action planning tools that supported the 2020 update of the Zero Carbon Communities Guide
- We provided community engagement resources such as a newsletter and meetings with councils
- Local Zero Carbon Communities presented to Climate Action Network Australia and other networks
- We provided support and on the ground resources to the Diversifying The Hunter Project

### **Zero Carbon Communities**

### Snapshot

One of the resources developed within our Zero Carbon Communities program is the Snapshot community climate tool which allows any individual to obtain greenhouse gas profiles for every local government area in Australia. In this year's highlights:

- Snapshot beta mode was developed and released in collaboration with sustainability consultants Ironbark Sustainability.
- Snapshot received support from state Government, local government authorities and community groups.
- Snapshot data was reviewed by Renew, Sustainability Victoria, ICLEI – Local Governments for Sustainability and the New South

Wales Department of Planning, Industry and Environment.

Snapshot profiles were released for all of Victoria and New South Wales in September 2019.

### Zero Carbon Communities Investment Reference Group

The Investment Reference Group works towards developing models which facilitate investment in community projects. This year:

- The Zero Carbon Communities Investment Reference Group saw growth in membership.
- Working groups were established to focus on specific types of investments.
- The program received support from the Global Consulting Group to deliver two projects to create resources to assist communities to source investment.

### Million Jobs Plan:

- Zero Carbon Communities was featured in BZE's Million Jobs Plan launched in June, highlighting the great ideas communities could invest in.
- The Hunter region was profiled in the Million Jobs Plan thanks to staff and local Zero Carbon Community members.
- The Long List Project Pipeline Database became a tool to highlight community interest and business and industry willingness to invest in hundreds of clean tech and zero emissions projects.

### Volunteers

BZE volunteers are sometimes matched to Zero Carbon Communities to provide specialist expertise. This year the Apollo Bay road map and community engagement program and the Together program with the Banyule Clean Energy Group both were matched with BZE volunteers to provide skills and support.

## **Diversifying the Hunter**

For decades the Hunter region of New South Wales was known as "coal country". But with the industry in decline, communities have been forced to adapt to new technologies and economic opportunities. In our Million Jobs Plan, we dedicated an entire section of the report to a vision of the region in 2030 with the Hunter retaining its reputation as one of Australia's great energy heartlands by making the switch to renewables.

### In this vision, a renewables-based economy for the Hunter means:

- 50,000 jobs created over the next five years including in housing retrofits, mine rehabilitation, fly ash reuse, green steel and electric buses
- 500% renewable energy in heavy industry and advanced manufacturing
- · Green hydrogen and metal production and export industry
- · Clean tech manufacturing for both domestic and export markets
- Healthy, comfortable homes that are low cost to run
- Creation of a massive carbon sink through partnerships with Indigenous custodians

Danielle Coleman, Hunter Renewal Project Coordinator commented:

The BZE Million Jobs report was key in giving our local government and community confidence that we have something to move toward, and is regularly referenced by business and local government leaders in discussions about how the decline of coal doesn't have to mean the loss of thousands of jobs.

Our next steps in the Hunter will focus on bringing elements of the Million Jobs Plan to life. Our local volunteers continue to actively support BZE's work, and we thank them all for their focus and efforts over the past year. Special thanks to volunteer Christine Rogers for her leadership of the Hunter team.

## **BZE Volunteers**

BZE provides great opportunities for volunteers to use their experience and skills to support our work. Volunteers join BZE for many different reasons; some wish to use their existing knowledge to support our research, others are starting their careers and building their experience and contacts, while others simply wish to make a contribution to our work.

No matter why volunteers join, they support a lean and effective model which makes best use of our resources, and ensures our work reaches the wider community.

We'd like to make special mention of our volunteers delivering two radio shows per week, through 3CR in Melbourne and podcasts. They have coped with the challenges brought by COVID and the need to put together regular radio shows from home. Thanks also to the volunteers who were running monthly discussion groups; these moved online in March 2020.

Volunteers are core to our research and engagement projects, and we thank everyone who helped to deliver *The Million Jobs Plan, Collie at the Crossroads, Zero Carbon Communities* and *Snapshot*. Volunteers completed a range of tasks from research and fact checking, to technical support and advice, to graphic design, editing, and administration.

Our active volunteer chapters in the Hunter and Gold Coast regions have continued to meet regularly.

**The Hunter chapter** was active with meetings, training sessions and events, including the annual Living Smart Festival in September and hosting a Climate Grief workshop in February before monthly meetings moved online from March 2020. The Hunter volunteers contributed substantially to the Million Jobs Plan, and the Zero Carbon Communities program. A successful grant application to the NSW government will result in an Energy Freedom Homes project, to be delivered in 2020/21. The chapter also raised significant funds in memory of volunteer Jennifer Bates who would have turned 40. Jennifer was the chapter leader until her untimely death a few years ago. The Gold Coast chapter was scheduled to hold its inaugural event in March, but this was cancelled by COVID; however the volunteers have held regular meetings online. In June, the chapter hosted an online webinar with Pamela Bessette-Guard, the Executive Coordinator of the City of Gold Coast Energy Management department, speaking about the Gold Coast's Sustainable energy future. The event attracted 62 attendees. COVID also gave the Gold Coast volunteers an opportunity to research the city, demographics and industry, finding out that 18.9% of jobs on the Gold Coast are in construction. The Gold Coast chapter is part of the Gold Coast Climate Action Network.

### NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 JUNE 2020

### Note 1: Statement of significant accounting policies

### **Financial Reporting Framework**

The Committee has determined that the Association is not a reporting entity because it is unlikely there are users of these financial statements who are not in a position to require the preparation of reports tailored to their information needs.

Accordingly, these financial statements have been prepared to satisfy the Committee's reporting requirements under the Australian Charities and Not-for-profits Commission Act 2012. The Association is a not-for-profit entity for financial reporting purposes under Australian Accounting Standards.

### **Statement of Compliance**

The financial statements have been prepared in accordance with the mandatory Australian Accounting Standards applicable to entities reporting under the Australian Charities and Not-for-profits Commission Act 2012. These special purpose financial statements do not comply with all the recognition and measurement requirements in Australian Accounting Standards.

### **Basis of Preparation**

The financial statements, except for the cash flow information, have been prepared on an accrual basis and are based on historical costs unless otherwise stated in the notes. The material accounting policies adopted in the preparation of these financial statements are presented below and have been consistently applied unless stated otherwise. Where applicable they indicate how the recognition and measurement requirements in Australian Accounting Standards have not been complied with. The amounts presented in the financial statements have been rounded to the nearest dollar.

### COVID-19

Prior to year end 2020, the World Health Organisation declared the novel coronavirus 2019 (COVID-19) outbreak a public health emergency.

During this time, the Association received other government incentives such as the Cash Flow Boost Payment which offset some of the revenue reduction, however, there is uncertainty regarding how long the federal government will have these changes in place, and the Committee is ready to adapt as necessary should there be any further changes or restrictions.

The Committee believe that they have instituted sufficient measures by way of reducing expenditure where possible, and utilising accumulated reserves where necessary, that the Association will be able to navigate these unprecedented economic conditions.

### a. Income Tax

No provision for income tax has been raised, as the entity is exempt from income tax under Div. 50 of the *Income Tax Assessment Act 1997.* 

### b. Cash and Cash Equivalents

Cash and cash equivalents includes cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of three months or less.

### NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 JUNE 2020

### Note 1: Statement of significant accounting policies (cont.)

### c. Trade and other receivables

Trade receivable and other debtors include amounts due from donors and any outstanding grant receipts. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

### d. Property, Plant and Equipment

Each class of property, plant and equipment is carried at cost or fair values as indicated, less, where applicable, accumulated depreciation and impairment losses.

The depreciable amount of all property, plant and equipment is depreciated over the useful lives of the assets to the entity commencing from the time the asset is held ready for use.

### e. Trade and other payables

Trade payable and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the company during the reporting period which remain unpaid. The balance is recognised as a current liability with the amount normally paid within 30 days of recognition of the liability.

### f. Employee entitlements

Provision is made for the entity's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits that are expected to be settled within one year have been measured at the amount expected to be paid when the liability is settled. Employee benefits payable later than one year have been measured at the discounted value of estimated future cash outflows to be made for those benefits.

### g. Provisions

Provisions are recognised when the Association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured. Provisions are measured at the best estimate of the amounts required to settle the obligation at the end of the reporting period.

### h. Impairment of assets

At the end of each reporting period, the entity reviews the carrying values of its tangible and intangible assets to determine whether there is an indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the asset's carrying amount. Any excess of the asset's carrying value over its recoverable amount is recognised in the income and expenditure statement.

### NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 JUNE 2020

### i. Revenue

Revenue is brought to account when received and to the extent that it relates to the subsequent period it is disclosed as a liability.

#### Grant income

Grant income received, other than for specific purposes, is brought to account over the period to which the grant relates.

#### Interest revenue

Interest revenue is recognised using the effective interest rate method, which for floating rate financial assets is the rate inherent in the instrument.

#### Donations

Donation income is recognised when the entity obtains control over the funds which is generally at the time of receipt.

All revenue is stated net of the amount of goods and services tax (GST).

### g. Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the assets and liabilities statement.

### h. Leases

### The Company as Lessee

### Exceptions to lease accounting

The Association has elected to apply the exceptions to lease accounting for both short-term leases (i.e. leases with a term of less than or equal to 12 months) and leases of low-value assets. The Association recognises the payments associated with these leases as an expense on a straight-line basis over the lease term.
